

## Conditions of Entry of the **Musical Composition Award** Paquita Madriguera 2016

The City Council of Igualada and the Municipal Music School, in collaboration with the Catalan Association of Music Schools (ACEM), announce the Musical Composition Award "Paquita Madriguera" with the aim of promoting musical composition with educational purposes.

A unique category of participation has been established:

A musical composition award for works with a length of 5 to 10 minutes, composed for a musical group without a soloist. This work can be formed by different parts or brief pieces. The group formation is free and it will be highly valued if works do not only have an artistic quality but also if they can be adapted to other instrumental groups of the music school.

An essential condition is that the works must be accompanied by a didactic proposal which presents and orientates the possible work that can be done, as well as the possible adaptations that can be made. Works not accomplishing these conditions will be dismissed.

Conditions of entry:

1st. The competition is opened to composers of any nationality, without age limit. The works must be unpublished and not shown before, and they cannot have been awarded in other contests.

2nd. The works must be submitted with a title. The name, the address and the telephone contact of the author must be stated in a sealed cover which will be externally identified with the same title that appears in the score. Inside the sealed cover there must be a photocopy of the ID or passport of the author.

3rd. The general score, along with the didactic proposal, must be printed in triplicate. The transmittal must also include a CD with the score and shorts cores in format Finale or similar and in format PDF, in order to be able to edit it immediately. All the works submitted must follow the *Creative Commons Licences* (by-ns-sa)\*.

4th. The **deadline** to submit the works is due **30 September 2016**. The works must be submitted to the *Departament de Promoció Cultural* (Plaça de Sant Miquel, 12, 2n, 08700 Igualada) via certified mail o personally, from Monday to Friday, from 8 am to 3 p.m.

5th. The "City of Igualada" Award and a 1.350€ endowment in concept for copyright will be granted. In addition, the City Council will produce a commemorative edition of the work which will be distributed to the music schools and conservatories in Catalonia the year after the award. The work will be included in the educational website [www.freeangle.org](http://www.freeangle.org) managed and promoted by ACEM.

6th. The winner of each edition will not be able to enter the next one, and he or she will be invited to join the Jury the following year.

7th. The compositions will be valued by a Jury of directors of musical groups in music schools, a representative of the Municipal Music School of Igualada, a representative of ACEM and the former winner.

8th. The Jury's verdict will be final. The Jury can grant runner-up awards without economic endowment, recommend the edition of the before mentioned runner-up award and declare the prize null.

9th. Non-awarded works can be collected until 31 January 2017 from the Municipal Music School (pg. Verdager, 84-86 d'Igualada). After the due date, the works which have not been collected will be destroyed.

10th. **The reading of the verdict and the award ceremony will take place on 20 November 2016**, during the award ceremony of the Artistic Creation Awards of the City of Igualada.

11th. The winning work of 2015 will be released during the awards ceremony of 2016. The winner commits himself/herself not to show the work before this premier and also to adapt it, if necessary, to the musical group which will play it.

11.. The winner agrees to reserve for this occasion the world premiere of the play and adapt, if necessary, set the template instrumental need to interpret.

12th. The winner/s or legal representatives who do not collect the prize during the award ceremony will lose all their rights.

13th. The Catalan Association of Music Schools will promote this work so that it will be played by the groups in the associated music schools.

14th. Participation in this contest implies full acceptance of and agreement with these conditions. Any issue not considered in this Conditions of Entry will be dealt with "City of Igualada" Award organization.

Començà a tocar el piano als tres anys. Estudià amb Enric Granados, el mestre Frank Marshall i Isidor Philipp. L'any 1912 fou admesa com a concertista al Palau de la Música Catalana. De molt jove va donar concerts a Madrid, Londres i París. L'any 1915 embarcà cap a Amèrica i oferí concerts a Nova York i a les principals capitals d'Amèrica de Nord i del Sud.

Als divuit anys ja havia escrit trenta-cinc composicions.

Després d'haver abandonat la seva carrera musical, en casar-se a Montevideo amb Arturo Puig, la va reprendre en enviduar i va donar concerts entre d'altres amb l'Orquestra Pau Casals.

Es casà en segones núpcies amb el gran guitarrista espanyol Andrés Segovia.

Entre les seves composicions per a piano i cant es poden destacar: Capvespre d'estiu. Non non, La boda índia, El canto del grillo, Pastoral, Atalaya, Serenata aragonesa, El petit regiment, Enyorant en Patufet, entre d'altres.
